Mediation Workshop: Mediation Skills in Restorative Justice and their Application in General Mediation

Why attending this workshop?

More and more mediators found it useful to equip themselves with different skill sets involved in different models of dispute resolution, e.g. **family mediation** and **victim-offender mediation (VOM)**, and many have expressed interest in learning **VOM** for **skills enhancement**.

What is Restorative Justice?

Restorative Justice (RJ) is an approach to justice that emphasises the repairing of the harm caused by criminal behaviour. It involves the parties to a dispute and others affected by the harm to collectively **identify harms**, needs and obligations so as to heal and restore relationship. VOM is one of the examples of RJ process.

What is covered?

Theories of Restorative Justice and Differentiation of VOM with other mediation models

The common situations and mistakes that a mediator may usually experience

Suggested remedies, skills demonstration, explanation and practice exercises Core communication skills to handle anger, distress, shame, to encourage parties to express their concerns and accept realities, to focus on restoring relationship interests rather than in position

Expression of regret/ forgiveness in mediation

Mediation Workshop: Mediation Skills in Restorative Justice and their Application in General Mediation

Over the past decades, interest-based approach has been successfully adopted to resolve conflicts and disputes. It is widely applied to family conflicts, workplace differences, community disputes and even international confrontation. Based on the merits of this approach, professional practices such as mediation, conciliation, and victim-offender mediation (VOM) have been developed. While these practices have their own unique features for serving different purposes, they nonetheless share the same provenance and many commonalities. In Hong Kong, more and more mediators found it useful to equip themselves with different skill sets involved in different models of dispute resolution. For example, many general mediators consider family mediation training beneficial to general mediation practice in terms of skills of handling emotional parties; many others also expressed interest in learning VOM for skills enhancement.

This workshop is organized for general mediators in Hong Kong to enhance their mediation skills and knowledge, through understanding of theories and skills of VOM.
