- It is with deep humility and gratitude that I accept this recognition from the Law Society of Hong Kong. After fifty years in this profession, I feel privileged to have had the opportunity to serve not only my clients but also the community and the legal profession at large.
- 2. Throughout my career, public service has been a cornerstone of my journey. Whether it was serving on panels and committees of the Hong Kong Housing Authority, the Hospital Authority, and the Chairman of the Appeal Board of Amusement Game Centres, or as Vice Chairman of the Hong Kong Housing Society, I have always believed that contributing to public institutions is one of the most meaningful ways we, as lawyers, can give back to society. These roles taught me the importance of fairness, responsibility, and the collective effort required to improve our community.
- 3. Among my contributions to the profession, one area that holds a special place in my heart is the development and promotion of mediation in Hong Kong. When I first began advocating for mediation almost three decades ago, I often felt like a lone voice in the wilderness. Solicitors were reluctant, even resistant, to embrace mediation as a viable alternative to litigation. What began as a struggle against ignorance and skepticism has now blossomed into widespread acceptance. Today, mediation is a well-established part of our legal landscape, and most solicitors recognize it as an effective tool for achieving cost-efficient, non-adversarial, and collaborative dispute resolution.

- 4. I was fortunate to contribute to this transformation through various roles, including serving on the Secretary for Justice's Working Group on Mediation and subsequently the Task Force on Mediation, where I chaired the Sub-committee on Public Education and Publicity. It was a privilege to work alongside so many dedicated individuals whose collective efforts, I believe, were instrumental in the significant progress we achieved. These efforts eventually led to two Government Policy Speeches by the Chief Executive of the HKSAR, which firmly promoted mediation as a key form of alternative dispute resolution. This policy drive laid the foundation for mediation to truly take root in Hong Kong.
- 5. Additionally, my work on the Chief Justice's Working Party on Mediation and the Civil Justice Reform Monitoring Committee allowed me to help shape policies that integrated mediation into our judicial processes. One of the milestones I am particularly proud of is founding the Joint Mediation Helpline Office. This initiative has become an important bridge between the public and mediation services, ensuring that mediation is not just a theoretical concept but a practical and accessible tool for resolving disputes.
- 6. While we have come a long way, I believe the journey is far from over. Looking ahead, I see the next step in the evolution of mediation in Hong Kong: the development of mediation advocacy. Mediation advocacy is not about winning or losing; it is about constructive
