Advanced Mediation Workshop - Mastering Mediation Challenges

This advanced workshop provides participants with the opportunity to experience firsthand the challenges in six mediation cases shared by a selection of international mediators across the globe. Participants will be asked to consider what they might do on a "mediation moment" when the case requires the mediator to ask themselves what to do next.

The workshop will include:

- ✂ Six mediation cases related to mainstream commercial and multiparty public interest disputes which are drawn from the world and designed for stretched learning purposes.
- ✂ Role plays, group discussions and experience sharing sessions that assist participants in analyzing the interventions required to achieve the desired outcome for each case.
- ✂ Discussions with several international mediators who mediated the cases.

Advanced Mediation Workshop - Mastering Mediation Challenges

The pedagogy aims to fulfill four higher levels of learning objectives in Bloom's taxonomy (application, analysis, synthesis and evaluation).

Expected learning outcomes are:

- ✂ Applying existing knowledge to solve new problems presented through the six mediation cases.
- ✂ Examining and identifying new mediation strategies, making inferences and finding evidence to support generalizations of mediation interventions for certain situations.
- ✂ Building a structure from the unpacking of the exchange of diverse views and opinions from participants and international mediators.
- ✂ Evaluating the views and opinions expressed by other participants and international mediators, and integrating new information into their own mediation practice.

Tat Lim is a dispute resolution practitioner based in Singapore. He is an alumnus of National University of Singapore and King's College London. He is a Fellow of the Chartered Institute of Arbitrators, an IMI-certified mediator and accredited with many distinguished arbitration and mediation institutions, including SIAC, SMC, SIMC, NMAS, CEDR, HKMAAL, ICDR, AMINZ, IAM and the Compliance Advisor Ombudsman, World Bank Group.

He has successfully mediated a broad spectrum of disputes, including commercial, construction, intellectual property, real estate, shareholder and joint venture, healthcare, family, public interest and cross border matters.
